CONVENTION ON THE BIOLOGICAL DIVERSITY

Article 8. In-situ conservación

Each Contracting Party shall, as far as possible and as appropriate:

(j) Subject to its national legislation, respect, preserve and maintain knowledge, innovations and practices of indigenous and local communities embodying traditional lifestyles relevant for the conservation and sustainable use of biological diversity and promote their wider application with the approval and involvement of the holders of such knowledge, innovations and practices and encourage the equitable sharing of the benefits arising from the utilization of such knowledge, innovations and practices;

INTRODUCTION

Functional foods are those foods that provide an additional benefit for the health, improving the quality of life. In some cases, its development has involved the experience and knowledge of indigenous communities which have been orally transmitted from generation to generation, also known as the traditional knowledge; as well as the biological diversity that the same communities have preserved.

How to achieve a sustainable development of functional foods, based on the traditional knowledge and biodiversity of Latin America, in such a way that it provides an equitable and fair benefit to the indigenous communities and to those who commercialize them? Why is it important to focus efforts of Europe and Latin America in this common development? How can the Intellectual Property Rights promote the equitable distribution of the benefits?

These are some of the questions that we wish to answer in the DEBATE ON TRADITIONAL KNOWLEDGE, BIODIVERSITY AND FUNCTIONAL FOODS, that will take place in the City of Mexico on March 31st and April 1st of 2008, organized within the framework of the activities of the EULAFF Project, "Europe-Latin America Action on Functional Foods", sponsored by the European Commission.
